Region 24 Emergency Management Agency is beginning the first phase of the Hazard Mitigation Plan update. Your jurisdiction is required to attend a meeting in order to participate in the plan. Once a community, county, or district (School District, Fire District, Irrigation District, etc.) is part of an approved plan, they become eligible for up to a 75% cost share from the Federal Emergency Management Agency (FEMA) for a variety of projects listed in the plan. **New FEMA directives state that you must participate directly in the plan to be eligible for this funding.** The plan examines regional and local vulnerabilities to a range of hazards (i.e. flooding, severe winter storms, drought, chemical spills, etc.) and identifies strategies and projects to reduce their impact.

The plan update process will last 9 to 12-months and will include two rounds of public planning meetings. **FEMA requires at least one representative from your jurisdiction to attend planning meetings.** Please **attend one** of the upcoming meetings shown below.
