Dear Hazard Mitigation Planning Participant,

The NNRD has secured grant funding from the Federal Emergency Management Agency (FEMA) and is in the process of updating its 2015 Multi-Jurisdictional Hazard Mitigation Plan (HMP). HMPs are a requirement of the Disaster Mitigation Act of 2000, administered by FEMA, and once a community, county, or district is part of an approved plan, they become eligible for up to a 75% cost share for a wide variety of projects listed in the plan. **You are receiving this letter because your jurisdiction is eligible to participate in this planning effort. You MUST participate in this planning effort to be eligible for these FEMA Hazard Mitigation Assistance grants.**

HMPs are required to be updated on a five-year cycle, and the NNRD's HMP will expire in July 2020. An HMP is a community-guided document that identifies vulnerability to disasters such as flood, drought, and chemical spills. The plan sets goals, establishes mitigation alternatives, and prioritizes projects which may lessen the extent of future disasters. For every \$1 spent on hazard mitigation, \$6 in post-disaster cleanup and rebuilding is saved, according to a 2018 study conducted by the National Institute of Building Sciences. Public input will be gathered throughout the duration of plan development through public meetings. All incorporated communities, counties, school districts, sanitary improvement districts, levee/drainage districts, and other taxing authorities within the NNRD are eligible to participate.

NNRD hired JEO Consulting Group, Inc. (JEO) to assist with plan development over the next 12 months. This HMP update is funded by a FEMA grant; the cost is shared 75% through federal funding and 25% through a local match. The NRD and participating counties are covering the local match.

The NNRD is beginning the first phase of the Hazard Mitigation Plan update. Your jurisdiction is required to attend a meeting in order to participate in the plan. Once a community, county, or district is part of an approved plan, they become eligible for up to a 75% cost share from the Federal Emergency Management Agency (FEMA) for a variety of projects listed in the plan. **New FEMA directives state that you must participate directly in the plan to be eligible for this funding.** The plan examines regional and local vulnerabilities to a range of hazards (i.e. flooding, severe winter storms, drought, chemical spills, etc.) and identifies strategies and projects to reduce their impact.

The plan update and approval process will last 9 to 12-months and will include two rounds of public planning meetings. Unlike the previous Hazard Mitigation Plan update, the County is no longer allowed to sponsor communities and attend meetings in their place. **FEMA requires at least one representative from your jurisdiction to attend planning meetings.** Please attend one of the upcoming meetings shown below. 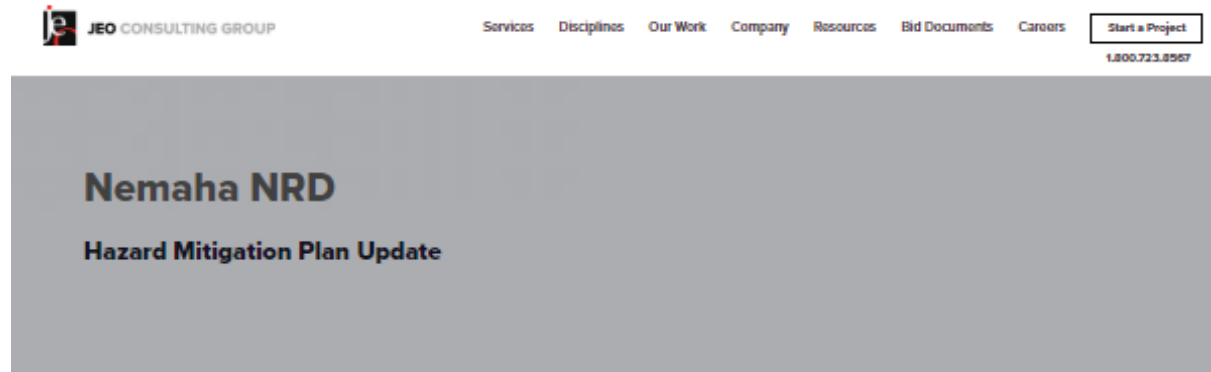

Project Purpose

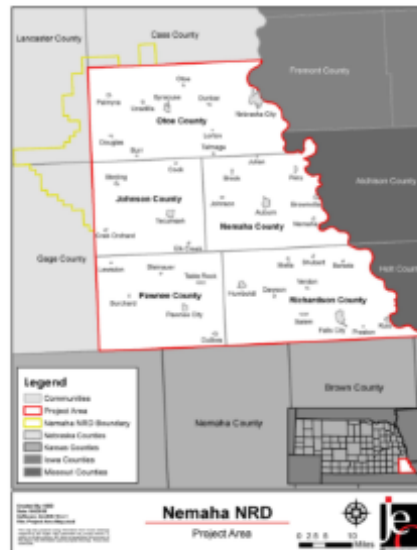
The Nemaha Natural Resources District (NRD) is updating their Hazard Mitigation Plan (HMP) with the assistance of JEO Consulting Group. An HMP is a community-guided document that identifies vulnerabilities to natural and man-made hazards, then determines mitigation projects to reduce or eliminate those vulnerabilities. This project also includes an NRD-wide assessment of drought vulnerability, and the development of a drought management plan for the City of Auburn Board of Public Works. Having an approved HMP is a requirement of the Federal Emergency Management Agency (FEMA) for jurisdictions to become eligible for Hazard Mitigation Assistance grants. An HMP will enable your community to be stronger and more resilient by:

1. Reducing your community's risk and impacts from disasters,
2. Gaining eligibility for pre- and post-disaster mitigation grants, and
3. Building partnerships with stakeholders within your community and region.

HMPs are required to be updated and approved every five years. The Nemaha NRD last updated their HMP in 2015. Throughout the planning process, members of the community are invited to participate by attending public meetings and providing information for the plan. Jurisdictions eligible to participate include:

- School Districts
- Fire Districts
- Local Health Departments
- Drainage Districts
- Rural Water Districts
- Sanitary Improvement Districts
- Other taxing authorities

This plan update is funded by a FEMA planning grant which offers 75% federal funding with a 25% local match. The Nemaha NRD is providing the 25% local match.
